## The Lewis Family.

### PIERRE LOUIS.

(Concluded from page 131.)

At this time a younger son of Jean Louis went to New York, where his descendants still live. The late Gov. Morgan Lewis [3 XL v p 107, Vol. IV. ED.] was of this family as also was Prof. Taylor Lewis. Another son of Jean went to Carolina and afterwards to the territory of Alabama. His descendants are yet in that state. Dixon H. Lewis, the fat Representative in Congress, for whom a chair had to be made was of this branch of the family.

### JEAN LOUIS.

By REV. H. E. HAYDEN, IN VIRGINIA GENEALOGIES.

Despite the "three brothers" tradition, so peculiar to American genealogy, there may be good ground for the account of the three Lewises and their settlement. But

this claim of descent from Jean Louis, Earl of Ligonier, is disposed of by Burke in his Extinct Peerage, where he gives the same history under the head of John Ligonier, Earl, Lt. Gen., Com. in Chief, etc., who was b. 1659 (?) and *died without* issue 1770. His nephew, Edward Ligonier succeeded.

The tradition of descent is, that Jean Louis, a lawyer of good fortune, fled to England from France about 1685, about the time of the revocation of the Edict of Nantes, bought an estate in Wales and had three sons, all lawyers. The youngest (name not given) emigrated to Virginia, located on Dragon Swamps, Middlesex Co., and was the head of the Zachary Lewis line. The second son (name not given) had gone to London to practice law, but having favorable accounts from his brother in Virginia, came on and settled on the Rappahannock. He was ancestor of Fielding, Howell, Robert (was this man's name Robert?) The eldest, Jean, settled in Ireland, died there, his son John, head of the Irish Lewis family, settled in Augusta-co., Va.

It is believed among the Virginia Lewises that these families are all of the same descent.

"*The same history*" spoken of above is Jean Louis of a Protestant family of Castres, fled from France to England about the time of the revocation of the Edict of Nantes (1685.) He joined the English Army, and for his gallantry and valuable services was made Field Marshall, Earl Ligonier and Baron Enniskillen. He was with Marlborough in Flanders and attracted his attention at the storming of Liege. At Blenheim he was the only captain of his regiment who survived. At Menin he led the grenadiers who stormed the counterscarp. He fought at Malplaquet where he was made major of a brigade, and was in all of Marlborough's great battles. At Dettingen as Lieut. General he earned still higher distinctions. At Fontenoy the chief honor was due to him for the intrepidity with which he led the British Infantry. In

1746 he was placed in command of the British forces in Flanders, but was taken prisoner at the battle of Lanfeld. Restored to England he was appointed Commander in Chief and Col. of the First Foot Guards. During his life he was in 19 pitched battles and 23 sieges (Smiles Hist. of the Huguenots.) This is the man whom John Lewis of the Zachary family makes the same as the lawyer of good fortune who bought an estate in Wales and whom Burke says died without issue 1770.

## GENEALOGICAL RECORDS.

### Explanations, Abbreviations, etc.

For convenience the records of the various Lewis families are divided into Books and each Book into chapters. At the head of each Book appears the name of the earliest known ancestor of that family. The List of Books is a complete index to the Books as published to this time. New Books will be added from time to time as new branches of the Lewis family are found. As soon as Books are proved parts of others they will be merged into the Books to which they belong. Each name is numbered when first printed and whenever the name is repeated this number follows in brackets. The abbreviations commonly used in genealogical work are used; as b. for born; d. died; m. married; m. (1) first wife; dau. daughter; unm. not married; v. p. see page; etc. Instead of repeating the name of a place in the same paragraph initials only are frequently given.

Miss Lewis has been employed in the postoffice for the past fourteen years, receiving the appointment of second assistant from the late postmaster, W. H. P. Steere. On the death of Mr. Steere in August, 1882, Miss Lewis assumed his duties which she performed with ability until March, 1883, when Mr. W. S. Brownell, the late incumbent of the office, was appointed."

#### CHAPTER LXXXIV.

By GEO. HARLAN LEWIS, N. Y. CITY.

Among the earliest settlers of Claremont, N. H., 1771, appears the name of Gideon Lewis, (878 v. p. 188, Vol. V) who had registered with the Town Clerk the marks for his sheep, cattle and swine. Also on May 9, 1771, he with others voted to call a minister at a Town meeting. Among the signers of the inhabitants of the town endorsing the action of the Continental Congress in passing a resolution to "oppose

the British Fleets and Armies" and "defend the Lives, Liberties and Properties of the inhabitants of the United Colonies" were Gideon (878) Samuel (881) and Seth (886) Lewis v. p. 188 Vol. V. In Capt. Oliver Ashley's Co. at Ticonderoga, May 1777, was Gideon Lewis. There is no mention of his being a minister there but he was, doubtless, a farmer. There is no further mention of Samuel or Seth.

William Lewis married Betsey Stewart Dec. 25, 1794, and had a son born Dec. 11, 1797, named Frederick Stewart. The records differ on spelling the name. This is probably some descendant.

The history gives the following which I send verbatim:

George G. Lewis, son of Wilca (probably Wilcox) and Elizabeth (904) v. p. 8, Vol. VI (Stewart) Lewis, was born in Claremont, N. H., July 7, 1800, and died at Worcester, Mass., Feb. 12, 1889. He descended from George and Mary (Fuller) Lewis in about the 8th generation. Wilca Lewis settled in Claremont about 1790, on a farm at East Side of Red Water brook. George G. Lewis' grandfathers, Jabez Lewis (880) and Jacob Stewart were both soldiers in the Revolutionary War, on the side of the colonies, and Jabez Lewis served throughout the entire war. George G. married Adeline Labaree, a great grand daughter of Peter Labaree, who was captured by a party of Indians at Charlestown in 1754 and carried to Canada with the Johnson family. Labaree afterwards escaped and returned to Charlestown, where he raised up a considerable family. George G. and his wife had 10 children born to them, 7 sons and 3 daughters. The oldest son, George William and the youngest, Herbert, died in infancy, the 8 others are still living.

Mrs. Lewis was highly educated for her time, had fine literary taste, great energy and ambition for her children, whom she encouraged and materially aided in obtaining good educations. The 5 surviving boys graduated at Dartmouth College, and



the girls were fitted to teach the higher branches of learning. She died Nov. 26, 1876. Of the five boys Eugene born in 1839, graduated at Dartmouth in 1864; read law with H. W. Parker of Claremont; was later admitted to the bar, and practiced for a time at Peterboro, N. H., and Moline, Ill., and is now living at Salt Lake City, Utah. Frank W. born in 1840, graduated at Dartmouth in 1866, read law with Henry W. Paine of Boston, and was admitted to the bar there; removed to Lincoln, Neb., and engaged in the business of Western investments. In 1893 he returned to Boston where he is acting president and eastern manager of the Merchants Trust Co.

Arthur G. born in 1845, graduated at Dartmouth in 1869, engaged as teacher and superintendent of schools, and is now principal of a grammar school in Worcester, Mass.

Henry E. born in 1848, graduated at Dartmouth in 1872; studied law and was admitted to the bar in Illinois; moved to Lincoln, Neb., in 1881, and was engaged in making western investments for eastern parties. From 1889 to 1893 he was President of the Lincoln Safe Deposit Co., and is now Secretary and Treasurer of the Merchants Trust Co.

Homer P. was born in 1849, graduated at Dartmouth in 1872. Since leaving college he has engaged in teaching. At Davenport, Iowa, he was principal of the high school, from whence he went to Omaha, Neb., in 1883, since which he has been principal of the high school there.

Of the daughters, Ellen A. born in 1838, married John Bugbee of Hartford, Vt., and now resides there.

Belle H. born in 1842, has for several years been assistant teacher in the high school at Omaha, Neb.

Marion born in 1843, lives at Salt Lake City, where she has been chiefly engaged in teaching. This is a remarkable record of a family of 8 children of a New Hampshire farmer of moderate means, due

largely to the intelligence, ambition, frugality and industry of the mother, in co-operation with the father and the children themselves.

## CHAPTER X.

FROM SMITH'S HIST. OF DELAWARE-CO., PA.

Ellis (1 v p 190, Vol. IV. and p. 123, Vol. V.) Lewis was born in Wales about the year 1680. His father dying while he was quite young, his mother married Owen Roberts. They all appear to have been Quakers, and about the year 1698 made arrangements for migrating to Pennsylvania. They had proceeded so far as to forward their goods, but severe sickness of the family obliged them to remain. After being restored to health they did not carry out their original design, but removed to Mount Molock, Ireland, where they resided till 1708, when Ellis obtained a certificate from the meeting at that place and came to Pennsylvania. Being a Welshman he met with a kind reception from the Welsh Friends of Haverford, a number of whom were probably his relatives. The next year 1709 he removed within the bounds of Concord Meeting, and in 1713 was married to Elizabeth, the daughter of Nathaniel Newlin. In 1716 he removed to Kennet, and, his wife dying in 1723, he some time

afterwards married Mary Baldwin. In 1749 he removed to Wilmington and died the next year aged 70 years. He is said to have been a man of good understanding, and was frequently concerned in settling differences amongst his neighbors.

EVAN LEWIS, Wales to Penn., 1682.  
CHAPTER VII.

By James J. Levick in an address read before the Penn., Historical Society, Mar. 13, 1893, on *The Early Welsh Quakers and Their Emigration to Pennsylvania.*

What manner of men were these who thusso promptly accepted the faith preached by George Fox and John ap John? Happily, this question can be readily answered. Still in Wales, especially in North Wales, their homes remain, retaining their old names though their former owners have long since passed away from them. Happily, too, by a law of their religious Society, certificates as to their character and standing were furnished the heads of every family removing to the New World. These "certificates" are individual or family biographies, and in these days when details of ancestry are so eagerly studied I know no reading so interesting, so instructive, so satisfactory as that which may be found in the minute-books of Radnor, Haverford, and Merion Meetings.

The family of Henry Lewis, of Trewern, near Narberth, has for centuries held a good position in Pembrokeshire, and the last of the family in Wales, who has lately died, was widely known for his philanthropy.

Six miles beyond Bala is Dolgelly—Nearby living at ease in his ancestral home, Bryn-Mawr, was Rowland Ellis (a yeoman descended from a prince of Powys), whose home has given us a

name so familiar to us that we may pause for a moment to describe it. It was then, as it is now, a comfortable stone house; the floors are of stone, and it was built by Rees Lewis, grandfather of Rowland Ellis, A. D. 1617, as an inscription on one of the rafters tells. To the right of the house are the remains of an ancient garden which has seen better days. Its walls are gone, but there are traces of old paths, while ancient box and venerable yew-trees tell of what has been. The view of the valley, the river running through it, and in the distance Cader Idris with its adjacent range of hills, and on the opposite side another long range of hills, the whole looking not unlike some of the prettiest part of Scotland, all make Bryn-Mawr well worthy of a visit.

And now, as I see before me this evening among the members of this Historical Society the descendants of Thomas Lloyd, of John ap Thomas, of Cadwalader ap Thomas, of John David, of Henry Lewis, of John Roberts, of Hugh Roberts, of Thomas Wynne, of Edward Jones, of William ap Edward, of Rowland Ellis, of Robert Owen, of John Bevan, of Edward Foulke, of Robert Cadwalader, of Rees Thomas, of Ellis Pugh, and others, and know that not only are they useful members of the Historical Society, but are also useful members of the community in which they live; know, too, that the lines have fallen to them in pleasant places and that they have here a goodly heritage, I think that they owe—**SONS OF THE FOUNDERS**, I think that we all owe—a debt of gratitude to one Morgan Lloyd, a priest of Wrexham, [the seat of the ancestors of Elihu Yale, the benefactor of Yale College, whose tomb is there in St. Giles churchyard,] who sent two of his men to the north of England to try the Quakers and bring back an account of them. **SONS OF THE FOUNDERS**, I think we owe a debt of gratitude to that messenger, John ap John, who abode in the truth and received a gift in the ministry, to which he

remained faithful, and who in the exercise of that ministry wrought such results as have so closely bound his life to our lives. SONS OF THE FOUNDERS, I think we owe a debt of gratitude to those brave men and gentle women who gave up their own homes, braved the perils of the deep, endured the hardships of a new and untried world, not for themselves, but for those who were to come after them,—for you and for me.

They were both members of the religious Society of Friends William being frequently called upon in the administration of the affairs of his meeting.
