Laws of Loyal Lewis Legion.

Be it decreed by the Supreme Castle of the order of Loyal Lewis Legion:

I

This order shall confer three degrees in the following order: the third or adoption degree; the second or cousinfraternal degree, and the first or homecouncilors degree.

11.

After the charter shall be closed, duly qualified persons may become members of the third degree, and members of the third degree may be advanced to the second degree, and second degree members may be promoted to the first degree, upon written application in due form, followed by election and initiation.

III.

Honorary members may be admitted to the third degree only, provided he or she is a member of the family of an active member; but an honorary member may become an active member upon application and election.

IV.

Upon the initiation or adoption of an active member a numerical number shall be assigned as the especial property of such member and their name and number enrolled in the supreme docket, and so long as he or she shall remain in good standing in the order, shall be entitled to receive a copy of LEWISIANA as issued, the subscription to be pail by the order.

ν.

Upon promotion to the first or councilors degree the member shall be decorated with the badge of the order, which shall be in the form of a button or pin of the size of a dime, in gold, emblazoned with the letters "L. L. L." the Greek letter "Delta," and an eagle with a pen in its right and a sword in its left talon; and on the reverse side the members number shall be engraved.

VI.

The degree fees and annual dues of members of this order shall be: In the third degree, fee \$3 and dues \$1.50, In the second degree \$2 and \$1 dues. In the first degree, fee \$1 and dues 50c. A member may become a life member upon the payment of Honorary members fees shall be one dollar, and no dues, and upon becoming an active member the fee, shall be applied upon the fees required of active members. The annual dues are payable in advance, in the degree only of which the member shall belong: the intention being to encourage members to take all of the degrees and thus reduce the annual dues.

VII.

The colors of each degree shall be: red in third, white in second, and blue in first, and the banner shall be the flag of the United States, in silk; and the flower, "FLEUR DE LIS."

VIII.

The motto of the order shall indicate and signify the GOLDEN RULE or "PUT YOURSELF IN HIS PLACE" and expressed by the word "RECIPROCITY."

IX

The officers of the Supreme Castle shall be:

Supreme Chancellor and Vice Chancellor, who shall discharge the duties usually devolving upon executive officers:

Supreme Herald and Deputy Herald, who shall discharge the duties usually devolving upon secretaries:

Supreme Marshal and Deputy Marshal, who shall discharge the duties usually devolving upon treasurers:

Supreme Master of the Rolls and Deputy Master, who shall discharge the duties usually devolving upon a librarian and historian;

Supreme Prelate, who shall discharge the duties appertaining to that position and calling;



Supreme Health Defender, who shall be and have and receive the honor and dignity of physician and surgeon;

Supreme Auditor, who shall audit and pass on claims and bills against the order.

Χ.

The business of the Supreme Castle shall be transacted by correspondence until further order.

ΙY

The Herald and the Marshal shall procure well bound books, in which to keep all records; all moneys belonging to the order shall pass through the hands of the Herald, who shall keep account thereof, and then shall pay the same to the Marshal who shall safely keep and pay out only upon warrants duly signed by the Chancellor or Vice Chancellor, Herald and Auditor; and no warrant shall be signed by said officers until the claim shall have been audited and allowed by the Auditor; and no indebtedness shall be made or incurred against the order, its funds, or officers, until authorized by the Supreme Castle or Its executive council; the Herald shall keep the supreme docket, and record the names of members alphabetically, and also in the order of becoming members, and all active members shall be in a list by themselves and numbered consecutively, which number is the property of such member; the Constitution, Laws and Proceedings shall be recorded in the supreme docket; and the Master of the Rolls shall safely keep all photographs, and books, pamphlets, manuscripts and literary matter belonging to the order. Members are expected to furnish gratis to the order copies of all printed books, pamphlets, and other matter written, composed or produced by members of the order.

HY

Until further decree members may

be admitted as charter members to the third or to all of the degrees, by paying \$6 fees and \$1.50 dues, and signing the Constitution or authorizing the Herald to sign their names to it, and answering the genealogical questions and furnishing a photograph taken within three years of admission to membership.

XIII.

The following form of application for membership (the blanks being properly filled) shall be deemed sufficient:

7. When and where was husband or wife born; and if deceased name time, place and cause of death and where buried?

8. If re-married give same information as if especially interrogated?

9. Occupation or profession, politics and religious belief?

10. When and where educated, and name civil, army or naval service?

11. Name and give dates of birth of children?

12. What is your motto, family history and traditions, including residences?

XV.

Henry B. Lewis (42 v p 132 Vol. V.) the "Godfather of Englewood" (v p 159 Vol. X.) died June 5, 1901, at his home 6012 Indiana-ave. He had been ill only a short time, and death was unexpected.

Mr. Lewis was born in Madison co., N. Y., in 1825, He resided in that state until 1854, when he started West, finally locating in Chicago. Thirteen years later he removed his residence to "The Junction," and lived in that locality until the time of his death, For some time he was engaged in the wool commission business in South Water street. Of recent years he had been in the real estate business with his son-in-law, W. W. Carter, with an office at Wentworth ave., and Sixty-third street. He was active in educational circles in Englewood, and served for a number of years as a school trustee. The Lewis School, and Sixty-second st., Stewart ave. was named in his honor.

He was married in New York, over fifty years ago, and with his wife, recently celebrated the golden anniversary. Besides a widow Mr. Lewis left one daughter, Mrs. Carter, and three grandchildren.

I, Waitstill Lewis, of Lawful Age Do testify and Say that on or about the 4th June, 1778, Being engaged to come to this State with Mr. Joseph Homer in the Schooner Dove, the Deponent, heard....the Deponent being then passenger in the Schooner Susannah and further saith not.

WAITSTILL LEWIS.

Boston, 3 July, 1778.

On June 4th, 1778, the Schooners Dove and Susannah were lying in Harbor of Barrington, N. S., loading by permission of Court for Boston, and were seized as prizes.

State of Massachusetts Bay.

To the Honorable the Council of Said State.

The Petition of Waitstill Lewis, of



few days ago in a small fishing Boat from Barrington in Nova Scotia where he belongs with several Prisoners as by Receipts, who had been taken by the Enemy and Carried into Halifax, from whence they made their Escape, and by the assistance of your Petitioner have got off clear.

That your Petitioner has come here for no other purpose than to bring these prisoners and to purchase a small quantity of Provisions which are extremely scarce with us.

Your Petitioner therefore humbly requests your Honors to suffer him to purchase a few necessaries and to grant him a Pass that he may return Home unmolested by any American Armed Vessel. WAITSTILL LEWIS.

This is to sertefy that Waitstill Lewis in the Shallop Polly from Nova Scotia broat up to the states of Amaraca too prisoners that were taking and maid thear Eschape.

In Council Oct. 21, 1778: Read and Ordered that the Prayer of this Petition be so far granted that the Petitioner be hereby permitted to depart this State in a Small Fishing Vessel that he came in from Barrington in and he hereby has Nova Scotia Liberty to purchase five Bbls. Flour and fifteen Bushells of Onions for the use of his Family and Several Families in said Town of Barrington in Nova Scotia. And the Commanders of All armed Vessels and belonging to this State are hereby Ordered, and it is recommended to the Commanders of all armed belonging to the United States to suffer him to pass unmolested to Nova Scotia with the articles aforesaid.

On Feby. 5, 1720-1, Elizabeth Lewis deeds "to her son, William Lewis, of Lyme" all her right in land from her father, John Huntley, formerly of Lyme. March 2, 1749, Hannah and Jonathan Beebe, Jane and Jonathan Smith and Elizabeth Lewis, all of Lyme, conveyed to Elijah Smith of Lyme, all their rights "in the Sunkapaugasut land,

in East Society of Lyme, that belonged to our honoured grandfather, Mr. William Borden." This land lay near Bride Brook Pond.



THE LEWISES OF WARNER HALL.

Now there was a John Lewis (v p 10 Vol. IX) who has better claims than either Robert (v p 154 Vol. XI) or Major William Lewis (v p 184 Vol. XI) to be considered the propositus of the family of Warner Hall (for coatof-arms v p 114 Vol. IX.-ED.) This was John Lewis (595), who patented 100 acres in Warwick co. at the head of Deep Creek, and in 1653 patented 250 acres on a branch of Poropotank Creek, in Gloucester co., which branch was then called Lewis' Creek, but formerly Totopotomoy's Creek. At the foot of the latter patent are given the names of those on account of whose importation he was entitled to the land (i. e. 50 acres for each), viz. John Lewis, probably himself; Lydia Lewis, probably his wife: William Lewis, Edward Lewis and John Lewis, Jr., probably his sons. William Lewis may have been Major William Lewis (4 v p 184 Vol. XI), already mentioned, Edward Lewis, patented lands on the Rappahannock and King and Queen, and 'John Lewis, Jr.," had a grant in 1655 for 250 acres at the main swamp of Poropotank Creek. As "Mr. John Lewis," he patented April 22, 1668, 100 acres in New Kent, northeast side of Cainhow's Swamp, and in 1667, 2600 acres in New Kent and Gloucester on both sides of Poropotank Creek, "next below the plantation of said John Lewis," 600 acres of which was granted to said John Lewis by patent dated November 23, 1663. His residence in 1676 being near Major Thomas Pate's, where Bacon encamped, he suffered severely



from the depredations of his troops. In 1680, he was captain of horse in the militia of New Kent, and one of its justices. New Kent then took in King and Queen co. as far down as Poropotank Creek. In 1675 he was termed major (in the foot service) and patented in New Kent 10,000 acres with Lieut. Col. John Smith, Capt. Philip Lightfoot, Mr. Thomas Royston and Mr. John Buckner (General Court Records).

FAMOUS NEW YORK FAMILIES.
XVI. THE LEWISES.

Among the many brilliant New Yorkers of the eighteenth century there is no better illustration than Francis Lewis, (1) a signer of the Declaration of Independence. His father was the rector of the Parish of Llandaff in Glamorganshire; his mother, the daughter of the Rev. Dr. Pettingal, rector of the Parish of Caernarvon. Both parents enjoyed a thorough culture, more than ordinary mental attainments, and high social position. From them he inherited a love of learning, and especially of poetry

and romance. The death of his mother when he was but a child threw him under the influence of an aunt named Llanwelling, who was a noted scholar in a community where everyone was imbued with literary tastes. She taught Lewis the Cymric language and the literature and history of its people. The death of his father transferred his guardianship to his maternal uncle, the Dean of St. Paul's.

The latter admired the mental abilities of the boy and saw, or thought that he saw, in him the embryo of a great divine. He sent the youth to Westminster, where he proved a scholar of aptness and ambition. Here he received a good English education, a fair knowledge of Greek and Latin, and some instruction in French. Upon finishing the curriculum of Westminster, he went to the Scotch Highlands to visit a maternal relation. Here he acquired the Gaelic speech, a love of hunting and adventure, and a dislike of the English Government, It is worthy of note that his home in Glamorganshire and that of his kinsmen in the Highlands were centers of politicial disaffection. In after life he declared that before he had reached manhood's estate he was, without knowing it, a rebel against the British Administration. It was probably the opinions thus formed which prevented his taking orders, as had, been intended by his relatives, and induced him to engage in a commercial life.

William Lewis (4) was born in London Feb. 3, 1777, and married Martha King of Woodford, Essex, June 10, 1805. When about twenty-five years of age he left England for America in charge of a eargo of merchandise of which he was part owner. The vessel was captured on the high seas and taken into Christiansand where it and the cargo were confiscated and the erew and passengers were imprisoned.

After his release he came to this country with his wife and settled at Cape Elizabeth near Portland. From there he removed to Burlington, Vt. To support himself and his family he fell back upon his knowledge of paintacquired while in England. 218.11. Cornelia bapt. June 11, 1718, Among the portraits painted at this time were those of several of the officers quartered in the town. The battle of Plattsburg occurred while he was in Burlington and he attended the reception given to Com. Macdonough, who commanded the American fleet.

> Sometime about 1820, William came to Boston where his family subsequently joined him. He established his studio at 128 Orange street (now a part of Washington street) and during the next twenty years painted the miniatures and portraits of many hundreds of the citizens of Boston and the neighborhood,

The invention of the daguerreotype materially lessened the demand for the painted miniature and about 1840 he associated himself in business with his Salem probate records state that the son William K. who after an appren-



ticeship of seven years with William Underwood, had established himself as a manufacturer of pickles and preserves. This was the origin of the well known firm of W. K. Lewis & Bros. William Lewis died January 5, 1859 at his home in Linwood Place, Boston.
