Lewis met a Mr. Israel Rulin who knew her and through him application was made to the old squaw to purchase her freedom, but the oll squaw would not part with her.

In Vol. IV, p. 90, it states that William married Amy Wells. Was it not Amy Weld?

The name of Weld and Wells seems to have the same origin as far as the early settlers of Mass.. go.

Mr. Weld was evidently a man of wealth at that time. The great pond is in Jamaica Plain, West Roxbury, where there are numerous Welds at this time.

Col. Charles Lewis (5), the fourth son of the Founder, was killed at the battle of the Point, October 10, 1774. "He was esteemed," says Howe, p. 183, "the most skillful of all the leaders of the border warfare, and was as much beloved for his noble and amiable qualities as he was admired for his military talents." Hon. Alex. H. H. Stuart, M. C. for Augusta

District from 1841 to 1843, and during President Filmore's administration. Secretary of the Interior, 1850-'53, has communicated in the following lettersome interesting particulars as to Col. Charles Lewis, who, it seems, was the "Idol of the Army."

STAUNTON, Oct. 18, 1882. Col. John L. Peyton:

DEAR SIR:-I regret very much that I cannot give you any detailed account of Col. Charles Lewis, who was killed at the battle of Point Pleasant. in 1774. I remember being present at a conversation. about 1830, between my father and the late Andrew Reid (father of Col. Samuel Mc D. Reid) in regard to him Mr. Reid had served under Col Lewis in 1774, and was actively engaged in the battle of Point Pleasant. Col. Charles Lewis was a younger brother of Gen. Andrew Lewis. Gen. Andrew Lewis was represented to have been a man of reserved manners and great dignity of character,-somewhat of the order of George Washington. His vigorous intellect, unquestionable courage and solid virtues inspired unlimited confidence in all who knew him. but there was nothing showy or attractive about him. Charles Lewis, on the other hand, was represented by Mr. Reid as being a man of brilliant talents, of most engaging manners, and. as Mr. Reid expressed it, "the idol of the whole army." My father, who was a much younger man than Mr. Reid, and had no personal acquaintance with Col. Charles Lewis, but was familiar with his character, as described by his cotemporaries, concurred with Mr. Reid in the high estimate which he had formed of his abilities and noble qualities, and they agreed in expressing the belief that if he had not been prematurely cut off he would have been a conspicuous figure in our Revolutionary war. Mr.

Reid said the death of Col. Charles 263.III. Herbert Levi b. Nov. 18. 1500 Lewis threw gloom over the whole army. Respectfully yours, etc.

Sanford Cummings Lewis was born at Lewis' Corners, in the town of Pompey, in 1814. His father was born in Connecticut in 1781 and came with

his family to Utica, afterwards moving into Onondaga county. His great-grandfather was born in 1747, and here we find three generations covering the period of our National life. Mr. Lewis was a sturdy farmer, of Angle Saxon race and a firm believer of God, the Father Almlghty. He is survived by one sister, and a son, Richard.

65. Ancestry of this Rev. John Vaughn Lewis desired.

"Frank E. Lewis, son of Rev. John Vaughn Lewis, D. D. formerly rector of St. John's church in Delhi, N. Y.. was shot and killed by an Indian at Pine Ridge Agency, South Dakota. in 1890. He was a teacher in the Indian school there, and was shot as he was leaving his school. The telegram states that the Indian who did the shooting was dying of consumption and expressed the determination to have a white man die with him. The Indian immediately after the shooting committed suicide.
