

Lewis High School.

It was while Rev. David L. Ogden, then pastor of the Congregational church here (1828) and who was foremost in his efforts to furnish for the young people of the town facilities for a more advanced education, that Miss Sally Lewis made provision in her will donating certain real and personal properties (which afterwards realized the sum of \$3,040.76), "to be held in trust, and the rents, interest or income thereof to assist in maintaining a school of the higher order within the limits of the first school district in Southington forever: that is, a school for the instruction of youth in the Latin and Greek languages, mathematics, geography, and other branches of science higher than are taught in the common schools."

The provisions of the will were carried out, a school building erected on the site of present Town Hall, and a school of a high order was opened. Hon. H. D. Smith being its first principal; and for several years the school was partly supported by this fundabut subsequently, one of the conditions was violated, and it reverted to the Congregational Society in accordance with a clause in her will.

Later (1838) Mr. Addin Lewis. a native of the western part of the town, which now forms the eastern part of Wolcott, bequeathed the sum of \$15.000, five thousand of which was to be used "in erecting near the present center of said town a building suitable for the accommodation of an Academical Institution."—Southington Phoenia.

Nath'l Lewis, ensign of Capt. Asa Bray's Co., Col. Noadiah Hooker's Regt. Arrived in Camp Apr. 3. 1777, disc., allowing 5 days to return May 15.

Nathaniel Lewis, private, Capt. Amasa Mills' Co., arrived in camp June

or July 1778.

Nath'l Lewis, Clarke, on pay roll of Capt. Nichols' Co.. Light Dragoons in Major Starr's Regt.. marched to New Haven etc. July 5, 1779, discharged July 16.

Nichcols Lewes, private on return of Capt. Bixby's Co., dated "Nobel Town," Nov. 18, 1776; time 30

days.

Oliver Lewis, private in Lieut. Thomas Bidwell's Co., which arrived at New York Aug. 19, 1776, discharged Sept. 24.

Peter Lewis, private in Capt. Peter Perritt's Co., enlisted July 10, 1775, discharged Dec. 21. This

was a Milford company.

Peter Lewis, private, Capt. Granger's Co., enlisted May 12, 1777, for during war, transferred to Invalid Corps June 1, 1782.

Peter Lewis, private, Capt. Allyn's Co., paid from May 1, 1781 to Dec.

31, 1781.

Philip Lewis, private, Capt. Wyllis' Co., enlisted June 3, '77 for 3 years; prisoner Dec. 10, '77.

Philo Lewis, private, Leavenworth's Co., enlisted Mch. 31, '77, for 3 years; discharged Mch. 3, 1780.

Robert Lewis, ensign, Capt. Eli Leavenworth's Co., commissioned July 6, discharged Dec. 10, 1775: re-entered service in 1776.

Robert Lewis, 1st Lieut. in Col. Chas. Webb's (19th Continental) Regt. in 1775—re-entered Cont. Service in 1777.

On page 1.3 in a note it says: Robert Lewis of Milford and Nathaniel Goodwin received appointments as Captains in Chas. Webb's Regt., Conn. Line," but died in the spring of 77.

New Books will be added from time to time as new branches of the Lewis family As soon as Books are are found. proved parts of others they will be merged into the Books to which they hilong. Each name is numbered when first printed and whenever the name is repeated this number follows in brack-The abbreviations commonly used in genealogical work are used; my b. for born; d. died: m. married; m. (1) first wife; dau. daughter; unm. not married; v.p. see page, etc.

Hints for Contributors.

In writing matter for the printer use only one side of the sheet, note paper preferred. In giving dates, give year, month and day whenever known. Write all middle names in full. Give names and addresses of such people as you think may be able to complete the record but get it yourself if possible and spure the editor. Old newspaper files, tomb stones, family Bibles and records, official records of the town, we hool and church, burial certificates,

county and probate records, old deeds and letters are some of the more important sources of information. Don't forget however the stores of information which the old people can give—Get them interested and then "pump them dry." Most important of all, don't get discouraged yourself. How can you interest others, if you yourself are not alive with enthusiasm?

Finding that no steps had been taken to replace the stores of ammunition destroyed at Concord, Col. Gay (v Phebe (186) p 118 Vol. V] urged the importance of providing at once powder and ball, or the patriot troops ar-

riving would be nearly helpless. He was persuaded to undertake the service, and visited the towns of Rhode Island and Connecticut to secure a supply. He was in a measure successful, collecting several tons of ammunition, either at this time, or later, when employed in a similar service by General Washington. The company of militia was raised and sent to Boston, and Capt. Gay received his commission as lieutenant-colonel Jan. 23. 1776, and that of colonel June 20, 1776. After General Washington's arrival at Cambridge, Colonel Gay was employed with his regiment to cover the party detached to fortify Dorchester Heights, and on the evacucation of Boston, he, with others. was ordered to march in and occupy the town. He remained with the army at Boston until his regiment. which belonged to Wadsworth Brigade. was ordered to New York. Being ill at the time he passed two or three days in Farmington with his family. but went to New York to join his regiment before he had recovered. became worse, and died in New York Aug. 22, 1776. On his sword were engraved these words: "Freedom or Death." He was a true patriot. zealous, self-sacrificing, giving himself for his country. Before engaging in the war he had been active in every good work, both in church and society, and his death was much lamented by the community.

[Col. Gay evidently became active in Farmington's welfare soon after his arrival (1759) as the following extract shows.—ED.]

In 1757, the society voted and agreed that they would introduce Dr. Watt's version of the psalms, to be sung on the Sabbath, and at other solemn meetings. At the same time Elijah Cowles was requested to "to tune the psalm," and for that purpose was as-

signed a seat in the fifth pew. 1762, Mr. Fisher Gay was appointed to assist Mr. Cowles "in setting the psalm."

He had four sons all Sea Captains, three of whom died and were buried at Sea. His youngest son Capt. James Morton McMichael, married an English woman, an only daughter, and her father built her a nice house. They had one son. When he was 10 years of age his mother died, his father then went to Philadelphia to live and the son J. Morton, McMichael, Jr., was a General in the last war and Mayor of the City, and held other offices.

OBITUARY.

Charles Smith Lewis who died on

Sept. 25, 1897, at the home of his wife's sisters, the Misses Sandford, in Pelham, N. Y., was the son of Chas. S. and Mary Griffitts Lewis. He was born in Baltimore, but in early life removed to Philadelphia, and later on to New York City, where he married a daughter of the late Gen. Sanford. Some time after, he made his home in Evona, a pretty suburb of Plainfield, N. J.. and now a part of that city. Here he established a lay-service in his own house, under the license of the bishop. The congregation soon outgrew the limited accommodations of the house and a new church became an urgent necessity. With true courage, he and his wife determined that a church should be built. They gave generously of their own savings, and sought help from their large circle of friends. Land was secured and very soon a pretty church of brick and stone was paid for, and consecrated. Soon a parish-house followed, and this sightly group of buildings stands to-day, as a memorial of the zeal and love of Mr. and Mrs. Lewis.

The church of the Heavenly Rest, well named, is his chosen restingplace, and there on the Feast of St. Michael and All Angels, the last words of the Church were said over his mortal part. His body waits the summons of the Resurrection Day, in calm and holy hope. Mr. Lewis be-longed to a family of clergymen. The late Dr. Mahan was his step-father, the late Dr. Stevens Parker his brother in-law, the Rev. Wm. Fisher Lewis, of Peekskill, N. Y., his brother, and the Rev. Charles S. Lewis his namesake and nephew. He learned early to love the church and her beautiful order of services, and though a layman he ministered with a zeal and fidelity that consecrated him. He was a man of singular purity of life devout and earnest, and his name will be precious in the sight of those who knew him best and loved him most. His wife survives him: his little son, their only child, had gone before him into Paradise.
